## 1.1 General

The National Universities Commission (NUC) appointed Cosset Consultants as consultants to carry out the Procurement Process Audit of the Africa Centre of Excellence on Technology Enhanced Learning (ACETEL), National Open University of Nigeria (NOUN). NOUN is one of the universities that are benefitting from the 17 Second Africa Higher Education Centres of Excellence for Development Impact (ACE-IMPACT) Projects.

## 1.2 Aim

The primary aim and objective of this Procurement Process Audit is to review the procurement, contracting and implementation processes and determine the extent to which laws guiding the procurement activities are complied with; and confirm their consistency with the ACE-Impact institutional guidelines and the World Bank general guiding principles. This audit also helps to identify noncompliances and deficiencies in the procurement activities and proffer appropriate corrective measures.

## 1.3 Methodology and Review Procedure

## 1.3.1 Methodology

The methodology and approach adopted for this post review are in three phases: (i) Inception activities (ii) Field works/activities (iii) Preparation and presentation of audit reports.

Generally, these phases include the determination of scope of assignment and selection of contracts to review. The study and evaluation of the Project/Contract files and other documents. Interactive meetings with the procurement staff. Data collection and analysis; physical site inspections; and the preparation of inception, draft and final procurement audit reports.

Data collection at the ACETEL was carried out with the use of checklists. Appendix II.





## 1.3.2 Review Procedure

The audit procurement procedure used at ACETEL is based on the institutional guidelines and it also considered the levels of compliances with the guidelines and the achievement of the Bank's procurement principles.

However, the procurement process activities of ACETEL are being implemented in consideration of section 15(1)a & b of the PPA 2007 Act as amended.

#### 1.4 **Contract Packages**

- i. The contracts presented as done by ACETEL in 2024 is six (6) in number. This is made up of seven (7) items of good, and one (1) work as shown in the inventory of sampled and reviewed contracts. Appendix 1.
- ii. The appropriate procurement methods to use for every contract based on the thresholds are stated. The actual methods used by the Centre are also stated as shown in Appendix 1.

## 1.4.1 General Procurement Methods






Figure 1 **GENERAL PROCUREMENT METHOD** (NO/%)**RFQ NCB** ■ RFQ - 16.67% (1NO) ■ NCB - 83.33% (5NO)

The dominant method used by ACETEL for the procured contracts was the National Competitive Bidding (NCB) it has 83.33% representation with five (5) contracts while the Request for Quotation (RFQ) has 16.67% with one contract. All the procurements were good contracts as shown on Figure 1. Table 1 above shows the values of the procurement methods.

## 1.4.2 General Procurement Types

All the six (6) contracts procured by ACETEL in 2024 were 100% goods. There were no works and services contracts. Figure 2. Table 1 above shows the values of the procurement types.

## 1.4.3 Sample Size

The audit sample size of 33.33% was determined by random sampling of the procured contracts. The selection considered the various procurement methods used as well as the procurement types. Table 3 and 4.

#### 1.4.3.1 Sample Methods

The NCB method was dominant. The sample size of 33.33% is made up of two (2) contracts. One (1) was procured using the RFQ. It makes up 50.00% of the sample size. One (1) item were procured using NCB and it constitute 50.00% of the sample size. Figure 3. Table 2 above shows the values of the sample methods.

1.4.3.2 Sample Types

Two (2) procurement types were used by ACETEL. It represents 100% of the samples reviewed and One (1). There were no works and services contract



reviewed. It is only goods and it represents 33.33% of the sample. No services contract was procured in 2024. Figure 4. Table 2 above shows the values of the sample types.

## 1.5 Findings

- 1. The Public Procurement Act (2007) as amended was used by the Centre of Excellence on Technology Enhanced Learning (ACETEL) in the 2024 procurement activities.
- 2. Standard Bidding Documents (SBD) were seen to have been used for the procurements.
- 3. Six (6) contracts were presented as procured for year 2024 by the Centre. This comprised of one (1) NCB contract and six (6) RFQs. Seven (7) of these were goods procurement while one (1) was a work contract.
- 4. The various approval boards and committees are well constituted and participated in the approval of the various contracts as presented by the procurement officer of the Centre. The various meetings were equally sighted. The analysis and evaluation of bids for the contracts were substantial.
- 5. The ACETEL has qualified procurement staff.
- 6. The analysis and checks of the bids prices was done and the results turned out substantial competitiveness.





- 7. On the average, payments were seen to have been made within reasonable time, from date of application to the date of disbursement.
- 8. Withholding Taxes (WHT) and Value Added Taxes (VAT) were deducted and evidently remitted to the relevant tax authorities.
- 9. The unsuccessful bidders were debriefed.

## 1.6 Exit meetings

An exit meeting was held where communications on the preliminary findings were discussed with the Centre staff. The few issues were discussed and resolved. The exit meeting data table is as in the attached appendix iii.

## 1.7 Infractions

There were no infractions identified from the reviewed documents of the ACETEL 2024 procurements activities.

## 1.8 Procurement Process and Activities Assessment

The team considered the performance of the general procurement processes and activities at ACETEL to determine the level of exposure to perceived infractions and inconsistencies. The procurement activities were categorized into low, fair and good, with percentages ranges of 0-39.99%, 40-59.99% and 60-100% respectively.

Overall, the ACE-TEL is adjudged to have achieved an aggregate "LOW" risk grading and a "FAIR" procurement efficiency/performance rating.

#### 1.9 **Rating and Classification**

The audit review opinion is classified and rated as shown on table 5 below Table 5:

#### 1.10 **Audit Opinion**

This opinion considered the contents of the compliant ratings as shown in table 6; which basically was the aggregate effects on the institutional guidelines, the Public Procurement Act 2007 and the WB general procurement principles. The ACETEL, National Open University of Nigeria procurement activities of ACE-Impact projects **NEEDS IMPROVEMENT.** The assessed mark is Seventy-Four percent (74%).

- 2. The Centre should be more detailed in evaluating bids.
- 3. The Centre is advised to ensure that necessary approvals are obtained for all respective procurement categories.
- Procurement training for staff of the Centre is still advised. It will help to 4. improve the procurement process and enhance results; with understanding of the PPA 2007 as amended and the application of the general procurement guidelines and principles.

## **SECTION 2 – INTRODUCTION**

## 2.1 BACKGROUND

Due to the need to promote regional specialization amongst Universities in the West and Central Africa sub-region within disciplines that address common regional challenges, the Africa Center of Excellence (ACE) Project aims at strengthening the capacities of these Universities to enable them deliver high quality training and applied research.

#### 1. Africa Centre of Excellence (ACE 1) Project

The Africa Centre of Excellence (ACE 1) project was instituted in 2013 by the Government of Nigerian, Ghana, Benin Republic, Togo, Burkina Faso, Cameroun and Senegal with support from the World Bank.

The Federal Government of Nigeria (FGN) entered into a credit agreement (Credit Number 5415-NG) after securing US\$70.0 million with the International Development Agency (IDA) of the World Bank (WB) to finance the ACEs project in 10 Nigerian Universities.

### 2. The Second Africa Higher Education Centres of Excellence for Development Impact (ACE- Impact) Project

The Second Africa Higher Education Centres of Excellence for Development Impact (ACE-Impact) Project resulted from the successes achieved with the ACE 1. ACE-Impact project has 43 Centres in the sub-region, with 17 of them being run by Nigeria Universities.

ACE-Impact project (Credit Number 6510-NG) was designed to inject \$115 million to the Nigeria University System (NUS).

## 2.2 THE AFRICA CENTER OF EXCELLENCE ON TECHNOLOGY ENHANCED LEARNING (ACETEL).

ACETEL stated that its "programmes are designed to build capacity in Artificial Intelligence, Cyber Security, and Management Information Systems courses at the postgraduate levels leading to the production of highly skilled human resource to drive the adoption and use of ICT solutions. It also offers short courses to bridge technology knowledge



gaps". It further stated that "the ACETEL research focuses on gaps, needs assessment of digital capacity development, solutions, and policy issues in the education and public sectors; effectiveness of green logistics information technology learning tools on students' academic achievement in STEM-related courses; developing smart digital learning tools for science in Open and Distance Education; impact of Cybercrime on Learners' Academic Performance and Research Data Integrity; and enhancing postgraduate learners' research skills using cloud computing learning tools."

## 2.3 NATIONAL UNIVERSITIES COMMISSION (NUC)

The National Universities Commission (NUC) of Nigeria is a parastatal under the Federal Ministry of Education (FME). It was established in 1962 as an advisory agency in the Cabinet Office and became a statutory body in 1974. NUC is a regulatory agency acting as a catalyst for positive change and innovation for the delivery of quality University education in Nigeria.

The **NUC** aims to: achieve a stable and crisis-free University System; upgrade and maintain physical facilities in the Nigerian University System for delivery of quality university education and match university graduate output with national manpower needs; work with Nigerian Universities to achieve full accreditation status for at least 80% of the academic programmes; foster partnership between the Nigerian University System and the private sector.

The National Coordination of the ACE projects is domiciled at the National Universities Commission (NUC). It is responsible for the National Project facilitation, training, and supervision in fiduciary aspects as well as national Monitoring and Evaluation (M&E) and minor Technical Assistance (TA) in Nigeria.



## 2.4 WORLD BANK PROCUREMENT GUIDELINE

The WB guideline has set rules guiding the procurement processes to be followed for procurement of good, works, consulting and non-consulting services being financed with loans from the WB. It covers the consideration of the WB core procurement principles in every contract.

However, the FG/NUC and the WB have agreed to allow the ACE-Impact Centres to use the various institutions guidelines for the implementation of the projects.

## 2.5 PUBLIC PROCUREMENT ACT (PPA) 2007

The Public Procurement Act 2007 as amended guides all procurement activities of the Ministries, Departments and Agencies (MDAs) in Nigeria. The PPA is regulated by the Bureau of Public Procurement (BPP). One of BPP's functions is to regulate and ensure the reduction of infractions, weaknesses and non-compliances aimed at reducing corruption in public procurement. It also aims to ensure value for money, economy, transparency, competition, fairness, integrity and accountability in public procurement activities; improved professionalism and enhanced service delivery.

The PPA Act 2007 as amended provides the basic guideline for the award and execution of contracts in Nigeria and promotes freedom of information that mandates all unclassified procurement records to be made available to appropriate public for inspection.

## 2.6 PROCUREMENT PROCESS AUDIT OF ACE-IMPACT

The purpose of the Procurement Audit of ACE-Impact is to study, verify, interpret, and critically analyze all data, documents and Procurement statement collected/received and form true, fair and independent opinion on the Procurement Statements of the Procurement operation of ACE-Impact (Nigeria) for the period under review and to report findings to the National Universities Commission (NUC).



## 2.7 OBJECTIVES OF THE ACE-IMPACT PROJECT PROCUREMENT PROCESS AUDIT

This Procurement Audit is to identify and report on negligence in procurement management operations and decisions. It is also structured to bring to light all fraudulent acts, weaknesses, deficiencies and noncompliances that negatively affect procurement activities and recommend deterrents and corrective actions to ensure improved processes.

The Procurement audit gave objective assessments of the procedures specified in the Credit Agreement and determine the levels of compliances with institutional guidelines with respect to the considerations of the World Bank guiding principles.

#### 2.8 **ENGAGEMENT OF COSSET CONSULTANTS**

The NUC engaged Cosset Consultants to carry out post review of the 2024 procurement activities of the 17 ACE-Impact Centres in fourteen (14) Nigeria Universities, including the ACETEL, National Open University of Nigeria.

#### 2.9 **METHODOLOGY**

- 1. The methodology adopted for this assignment is generally concerned with investigations, inquiry, assertions, reasoning and research. The approach is objective, verifiable, and quantifiable. Interactions and interviews were held with officers of ACETEL that were involved in the various stages of the procurement process/activities. The opinions and clarifications from the ACETEL staff are considered and addressed in the report.
- 2. Contract data forms are used to collect the information that were analyzed. The contents of the forms include information on general contracts, procurement and contracting, costs, time, contract administration, disbursement and deliverables. The documents made available to the consultant from which the data were collected include: (i) Procurement Plan (ii) Solicitation documents used before award (iii) Contract files (iv) Payment Vouchers, (v) Cash Book.
- 3. Visits to selected project sites were undertaken to determine the quality of materials and labour deployed to the work(s) by the contractor(s). It also helps to determine the level of supervision from the ACETEL procurement staff.





- 4. This data analyzed enabled the determination of the following critical success factors;
- Compliance with the provisions of the World Bank Procurement (1) Guideline.
- (2)Compliance with the provisions of the Public Procurement Act 2007 (examine the Management Control Framework in place to monitor procurement and contracting activities within ACETEL Project).
- Compliance with the use of standard bidding documents (examine (3)procurement documents and contracts files issued between the stipulated periods).
- (4)Compliance with the Code of Conduct for Public Officers involved in Procurement (review the processes undertaken by personnel of the ACETEL Project who are directly involved in procurement and contracting activities).
- (5)Optimized commercial performance and value for money (review related procurement procedures, guidelines and processes and determine the level to which value for money was achieved).
- 5. Exit meeting was held with the procurement staff of the Centre. The observed key weaknesses and non-compliances were brought to their notice. The explanation given by the Centre staff are considered in the report.

## **SECTION 3 – SCOPE AND REVIEW SAMPLES**

#### 3.1 **AUDIT SCOPE**

The procurement audit covers the review of all the procurement transactions, limited to the samples selected for audit, including prices reviews and compares of similar rates as at the time of award. Selected project site and inspection of procured goods, works and services are expected to be taken into consideration. The scope incudes determining the following:

- i. Whether the procurement statements from the ACETEL unit conform to accepted procurement procurement principles in accordance with the NUC/WB guidelines.
- ii. Whether they fairly represent the financial position of the ACETEL project.
- iii. Whether the results of operations for a given period are accurately represented.
- Whether the procurement statements have been altered. iv.

#### 3.2 **REVIEW SAMPLE**

During the field work, ACETEL presented a list of six (6) procured items in 2024.

Two (2) procurements were selected for review. The selection was 33.33% of the procured items and amount to about 46.30% of the value of the procured contracts.

The field work at the ACETEL was based on data sourced from available documents and information received from the Center's procurement unit.

This audit review was based on information extracted from the Center's Procurement Plan, as well as other documents made available to the Consultant by the ACETEL staff. There were also interviews and interactions with key personnel. The value of the six (6) contracts was N405,624,736.75.



## SECTION 4 - SPECIFIC CONTRACTS/PROJECTS DETAILS

#### 4.1 PROCUREMENT OF BRAND-NEW HILUX 4WD. SPEC PETROL ENGINE, DOUBLE CABIN, AIR-CONDITIONER.

#### 4.1.1 Introduction

The process for the procurement of the Toyota Hilux 4WD was initiated on November 13, 2024 by inviting three (3) OEM/Dealers to submit quotations. The selection was from the list of OEMs shortlisted by the BPP to use for such procurements.

The three (3) vendors submitted quotations within the bids submission deadline of November 28, 2024. The bids were opened, evaluated and the award made to Messrs R.T Briscoe Nig. Ltd, of 410, Cadastral Zone, Opp. NNPC Filling Station, Jabi Airport Junction, Abuja who made the lowest bid offer of Ninety-One Million Eight Hundred and Ninety-Five thousand Naira (N91,895,000.00). At the date of award, this amount is an equivalent of USD55,980.63 (at N1,641.55/\$), and it is about 0.93% of the Bank financing.

The vehicle was delivered on December 23, 2024 after payment by the Centre on December 16, 2024 as agreed by the partiespayment before delivery.

#### 4.1.2 **Observations/Findings**

The observation with the procurement process are as follows:

#### 4.1.2.1 **Procurement Planning**

The procurement is in the signed 2024 Procurement Plan.

#### 4.1.2.2 **Advertisement**

This was not advertised. The Centre selected bidders from the list of OEMS approved by the BPP.

#### 4.1.2.3 **Pre/Post Qualification**

Prequalification was not used. However, the assessment of the bidders has been done by the BPP.

#### 4.1.2.4 Competition

The process was competitive.



#### 4.1.2.5 **Bid Opening**

The bid opening was carried out with all necessary information recorded on the bid opening sheet, independent observers and the bidder's representatives were present.

#### 4.1.2.6 **Bidding Documents**

The materials for the bid were the Standard Bidding Document (SBD). The bidding documents were well prepared, and they included the specifications of the vehicles.

#### 4.1.2.7 **Evaluation of Bids/ Proposals**

The bids were evaluated by the approve evaluation committee members and the report was presented on December 13, 2024. The lowest bidder, MESSRS R.T BRISCOE NIG. LTD was recommended as the most responsive for the award.

#### 4.1.2.8 **Awards of Contract**

The Award Letter dated December 13, 2024 was issued to MESSRS R.T. BRISCOE NIG. LTD at the sum of Ninety-One Million Eight Hundred and Ninety-Five thousand Naira (N91,895,000.00).

#### 4.1.2.9 **Contract Documents**

Letter of Award, the specifications and the submitted bid constituted the Contract Documents. There is also the Acceptance letter.

## 4.1.2.10 Contract Implementation

The contract implementation was good. The vehicle was delivered within 40 days from the commencement of the process and within 10days from award of contract.

## **4.1.2.11** Payments

A one -off payment of N91,895,000.00 (gross) was made on time as agreed.

## 4.1.2.12 Physical Inspection

Physical Inspection of the vehicle was carried out and the team was satisfied.





#### 4.1.3 **Recommendation**

The Centre should always commence the procurement process on time to avoid the use of procurement method that has less competitive and transparent attributes than the NCB.

#### 4.1.4 Conclusion

There is need for more training for the procurement staff. The few observed lapses can be avoided with consistent staff trainings, workshops and seminars on procurement.



## 4.2. PROCUREMENT AND INSTALLATION OF EQUIPMENT FOR THE UPGRADE OF EXISTING MULTI-MEDIA TEACHING RECORDING AND BASIC COMPUTER LABORATORY AT ACETEL

## 4.2.1 Introduction

This contract was included in the 2024 procurement plan of the centre. The procurement method used for this contract was NCB as advertisements were placed in two National Newspapers namely; The Awareness Times and The National Express. The goods were for the upgrade of ACETEL computer laboratories. Four (4) quotations were received and analysed. The details of the analysis carried out are as follows;

- 1. MESSRS. PRIMETOUCH TECHNOLOGY LTD: N95,903,168.73 (completion period offered by the contractor was 8 weeks).
- 2. MESSRS. NATVIEW TECHNOLOGIES LTD.: N144,291,212.50 (completion period offered by the contractor was 9 weeks).
- 3. MESSRS. VAIL KONCEPT LTD.: N104,356,928.00 (completion period offered by the contractor was 11weeks).
- 4. MESSRS. GLAUBIG NIG. LTD.: N110,217,012.00 (completion period offered by the contractor was 12 weeks).

The contract was awarded to MESSRS PRIMETOUCH TECHNOLOGY LTD of 22, Neke Street, Unit Itaoluwo Road, Ikorodu, Lagos state; who was the least responsive bidder with the contract sum of N95,903.168.73 (ninety-five million nine hundred and three thousand one hundred- and sixty-eight-naira, seventy-three kobo). This is equivalent to USD 60,127.75 (sixty thousand one hundred and twenty-seven dollars, seventy-five cents) at N1,594.99 per dollar. It is about 1% of the Bank Financing. The award letter was issued on the March 18, 2024. The acceptance letter was dated March 21, 2024. The contract was completed on May 2, 2024, which is approximately Six (6) weeks from the date the contract agreement was signed, and falls within the 8 weeks completion period offered by the contractor.

The payments were made in three (3) phases. Below is the breakdown of the payments made;

 i. N28,770,950.63 (gross) – Being 30% payment for upgrade of multimedia laboratory. This was paid with voucher No: PV/2024/NOU-1/000000117 on March 28, 2024.



- ii. N38,361,267.50 (gross) Being 40% payment for upgrade of multimedia and basic computer labs. Made with voucher No: PV/2024/NOU-1/000000173 on May 3, 2024.
- iii. N28,770,950.62 (gross) Being final payment for upgrade of existing laboratory; using voucher No: PV/2024/NOU-1/000000206 on May 23, 2024.

## 4.2.2 Observations/ Findings

The following observations in respect to the process were made during the review:

## 4.2.2.1 Procurement Planning

The contract was included in the procurement plan of the center for the year 2024.

## 4.2.2.2 Advertisement

Proper advertisements were made on two newspapers namely: Awareness Times and National Express.

## 4.2.2.3 Pre/Post Qualification

There was no separate pre-qualification because of the threshold. Bidders were invited to bid based on their credibility and past performances records with the University.

## 4.2.2.4 Competition

The level of competition was commendable. Four (4) vendors submitted bids.

## 4.2.2.5 Bid Opening

- i. The bids were opened in the presence of bidders representatives, the procurement team of the Centre and some independent observers.
- ii. The bid validity period was also not stated.

## 4.2.2.6 Bidding Documents

Standard bidding documents were used for this procurement.

## 4.2.2.7 Evaluation of Bids/ Proposals

The bids were evaluated and analysed by the procurement committee. The report of the evaluation process was dated March 13, 2024. The University's Tenders Board approved the recommendations made by the procurement committee before award letter was issued to the successful bidder.





#### 4.2.2.8 **Award of Contract**

The contract was awarded to MESSRS. PRIMETOUCH TECHNOLOGY LTD., who was the least responsive bidder in compliance with Section 33 (1&2) of the 2007 Public Procurement Act, with the contract sum of Ninety-five million nine hundred and three thousand one hundred- and sixty-eight-naira, seventythree kobo (N95,903,168.73), and a completion period of eight (8) weeks. The award letter is dated March 18, 2024.

#### 4.2.2.9 Contract Documents Pre/Post Qualification

The contract documents included; the Standard Bidding Documents, the signed contract Agreement, letter of notification of award of contract and the acceptance letter.

#### 4.2.2.10 **Procurement Duration**

The procurement duration was 72days (up to the date the contract agreement was signed); which is quite long.

#### 4.2.2.11 **Contract Implementation**

The contract implementation was satisfactory.

#### 4.2.2.12 **Payments**

The payments were made in three (3) phases which are listed below;

- N28,770,950.63 Being 30% payment for upgrade of multimedia lab. Voucher No: PV/2024/NOU-1/000000117 on March 28, 2024.
- ii. N38,361,267.50 - Being 40% payment for upgrade of multimedia and basic computer labs. Voucher No: PV/2024/NOU-1/000000173 on May 3, 2024.
- N28,770,950.62 Being final payment for upgrade of existing lab. iii. Voucher No: PV/2024/NOU-1/000000206 on May 23, 2024.

#### 4.2.2.13 Physical Inspection

The audit team made physical inspection of the goods procured by the Centre and pictures were taken. Some are shown in the attached pictures in Appendix vii.

#### 4.2.3 **Recommendation**

Based on the audit process field work at the ACETEL, the Centre should;

- Ensure to use widely accepted nationwide newspaper for advertisements in other to ensure proper nationwide outreach. This will improve competition as more bidder could respond and put in their bids.
- The staff should be exposed to procurement.







It is essential that all necessary measures be put in place, to ensure seamless procurement results.



#### 3.1 TERMS OF REFERENCE
